# Condition of contract and guarantee

---

1. All service fees are to be paid in full prior to live service or collection.
2. All service fees are **non-refundable**.
3. All service fees and certificates apply to one mare only, should a second mare be inseminated then full payment of said fee to be paid for this mare.
4. Collections and transportation costs are the responsibility of the owner.
5. In the event that the Stallion is injured and can no longer breed then a full refund applies.
6. Live foal guarantee: Should the mare be determined not in foal after the 17 days insemination and or live serve, abort or give birth to dead foal then a full veterinarian certificate and written notification providing all details must be issues to Darlington Stud within 7 days. **The mare owner must provide Darlington Stud with a Veterinarians Certificate stating a positive pregnancy of 45 days for this live foal warrantee.**
7. **Darlington Stud will not honour a Live Foal Guarantee when the mare loses a pregnancy due to poor health and care caused by neglect.**
8. Mare owners are advised that all mares to be swabbed prior to the commencement of the breeding season and checked for soundness before breeding.
9. Service certificates cannot be issued without the appropriate registration papers, proof of ownership and identity of said mare.
10. All collections fees are the responsibility of the owner. Hawkesbury Equine has very reasonable rates .Please contact them direct on: 02 45774611. **Collection days are Tuesday to Saturday and Saturdays until 12 noon.**
11. All vet fees are the responsibility of the owner of the mare.
12. Mares leased by a third party all above conditions apply to the person leasing the mare.
